

## After you register for classes you have these options for payments:

### Pay **IN FULL**

You can pay your tuition in full by cash, check, credit card, or electronic bank transfer (E-Check). If you're paying by credit card in person, please bring identification (driver's license, state ID card, etc.) to confirm you are the cardholder. If you are NOT the cardholder, you will need to bring a letter from the cardholder authorizing you to use the credit card. If you don't bring the letter, we can't accept the payment.

- Cash is only accepted in person.
- Checks are accepted in person or via mail. (Check payments may be processed via Automated Clearing House by scanning your check and processing electronically to your bank.)
- Credit card payment is accepted in person, online, over the phone, or by mail. If you're paying by credit card in person, please bring identification (driver's license, state ID card, etc.) to confirm you are the cardholder. If you are NOT the cardholder, you will need to bring a letter from the cardholder authorizing you to use the credit card. If you don't bring the letter, we can't accept the payment.
- Electronic bank transfers (E-checks) are accepted online ONLY.



IF YOU MAIL YOUR PAYMENT, IT MUST ARRIVE BY THE DUE DATE FOR YOUR REGISTRATION TO BE HELD. IF PAYMENT IS NOT RECEIVED BY THE DUE DATE, YOU WILL BE DROPPED FROM YOUR CLASSES AND WILL HAVE TO RE-REGISTER.

### Pay Through a **FINANCIAL ASSISTANCE** Program

Once you've submitted your FAFSA, ICC will receive your information from the Federal Government in about four business days. We'll then begin to process your application for a financial award. If your tuition is due before ICC knows whether you'll receive financial assistance, you need to make other financial arrangements to cover your tuition and remain registered for your classes. To apply for financial aid for the academic year, you must:

- File your FAFSA online at [www.fafsa.ed.gov](http://www.fafsa.ed.gov) after you've filed your income tax return from the previous year. It's best to complete all of this paperwork before the middle of March. Submit your FAFSA with the ICC School Code #006753.
- Your eligibility status for the Pell Grant Program will be indicated on your Student Aid Report, which can be viewed online at [www.fafsa.gov](http://www.fafsa.gov).
- Once you've been awarded financial aid, you can view what aid you can expect by logging into eServices and selecting "View Financial Aid" under the Finances section.

If you are eligible for grant aid and have submitted all required paperwork for your application to be processed, ICC will hold your registration until your financial aid is applied to your account. If you are not eligible to receive enough financial aid to cover your account balance, you are responsible for paying the remaining amount.

### Pay Through An ICC Educational Foundation **SCHOLARSHIP**

If you're receiving an ICC Educational Foundation Scholarship, you can view your anticipated aid after you've registered for classes by logging into eServices. Select "View Financial Aid" under the Finances Section. Your registration will be held, but you will be responsible for paying the balance up front or setting up a payment plan option (see section below on Payment Plans).

*For example, if your charges are \$1530 for the semester and you receive a \$500 scholarship from the Foundation, you are responsible for paying the remaining \$1030. You may either pay up front in full or set up a student payment plan (if you have at least \$306 in remaining charges).*

Scholarship applicants receive a letter in the mail confirming their awards. Generally the Foundation sends this letter in early July.

If you have a scholarship from an organization other than the ICC Educational Foundation, you need to contact Ellen Tabor, (309) 694-5324.

### Pay Through a Student **PAYMENT PLAN** *(To set up a payment plan, you must have at least \$306 in remaining charges)*

ICC offers you several ways to pay your College bill, **based on when you register**. Please know that if you miss a payment on your plan, you will be charged a \$10 late fee.

**Partial payments without enrollment in an online payment plan WILL NOT hold your registration.**

#### **BLUE OPTIONS:**

**(Register for Classes Nov. 7 - Dec. 7, 2011)  
Tuition Due December 13, 2011**

- Option 1: Pay all tuition at registration.
- Option 2: Pay all tuition by December 13.
- Option 3: Sign up for an online payment plan\* between now and December 12.
- Option 4: Sign up for an online payment plan\* at registration. There is no down payment due at enrollment. Three equal automatic payments will be scheduled for December 13, February 29, and March 31.

#### **GREEN OPTIONS:**

**(Register for Classes Dec. 8, 2011 - Jan. 31, 2012)**

- Option 1: Pay all tuition at registration.
- Option 2: Pay tuition by due date listed on tuition bill.
- Option 3: Sign up for an online payment plan\* at registration. The minimum down payment is 1/3 of tuition. Two equal automatic payments will be scheduled for February 29 and March 31.

#### **RED OPTIONS:**

**Second 8-Week Classes**

**(Register for Classes Feb. 1 - March 24, 2012)**

- Option 1: Pay all tuition at registration.
- Option 2: Sign up for an online payment plan\* with \$102 minimum down payment. The remainder of tuition will be scheduled in an automatic payment for April 30.
