

RESIDENCY REQUIREMENTS AT ICC

GENERAL INFORMATION

As a public community college within the State of Illinois, Illinois Central College adheres to current residency requirements set forth by the Illinois Community College Board and the State Board of Education. With this in mind, students who are legal residents within District 514 are afforded a reduced tuition rate compared to other non-residents.

THE SPECIFICS

In-District Resident: A student who is a legal resident of Community College District 514 at the time of application to Illinois Central College or is a dependent of a person who has legal permanent residence within District 514 at the time of the student's application to ICC. Students who are 21 years of age or older and can prove independent status may also be classified as In-District*. Residence within Community College District 514 must be secured 30 days prior to the beginning of the term for which the change is being requested.

Out-of-District Resident: A Student who is a legal resident of any Illinois Community College District outside of District 514 or whose permanent residence is located outside the State of Illinois. Additionally, students who are classified as dependent upon a person whose permanent residence is outside of Illinois Community College District 514 are considered to be Out-of-District.

A student who temporarily moves into Community College District 514 for the purpose of attending Illinois Central College at the lower In-District rate **WILL NOT** be considered having established permanent residence within the District.

Any student claiming residency in District 514 may be required at any time to furnish college officials evidence supporting the residency claim.

Verification of In-District status should be submitted to the ICC Student Service Center at the time of submitting the ICC Application. Each appeal should be completed on the Residency Questionnaire form obtained in the Student Service Center. Residency determinations occur throughout each semester, but verification must be presented to the Student Service Center **prior to the earliest refund date** on a student's schedule to be applied to that term.

Proof of residency is determined by one or more of the following:

1. Voter registration in Community College District 514.
2. Payment of property taxes within Community College District 514.
3. Driver's license or vehicle registration showing an address within Community College District 514.

Military personnel and their dependents who have been transferred into Community College District 514 will be classified as In-District. The 30-day residency requirement will be waived. These students will still need to complete the Residency Questionnaire and provide valid proof of transfer.

Any individual who shows proof of full-time employment by a company located within Community College District 514 may only be expected to pay the In-District tuition rate. However, residency status will be determined based on the student's permanent address.**

Students attending Bradley University or Eureka College will only be required to pay the In-District tuition upon providing a copy of their current school ID card to the Student Service Center for verification. However, residency status will be determined based on the student's permanent address.**

Out-of-District students attending Illinois Central College by virtue of an approved Cooperative Agreement (Interdistrict or otherwise) or Chargeback will only be required to pay the In-District tuition rate at Illinois Central College.** For more information related to cooperative and chargeback agreements, consult the ICC Catalog.

*Students residing in WoodView Commons may only be required to pay the In-District tuition rate at Illinois Central College. However, residency status will be determined based on the student's permanent address.***
